This form is to be used for travel within Canada.

To ensure an efficient process, please complete and submit this form to reservation@harbourair.com at least 48 hours in advance of travel. Please also submit an identification card or other document that is issued by an organization or person specializing in service dog training that identifies the person with a disability and attests that the service dog has been individually trained by the organization or person to perform a task to assist the person with a disability with a need related to their disability.

Please note that should the form not be provided at least 48 hours in advance of travel, your service dog may be refused travel at the airport. Please ensure to always keep the completed form with you while travelling.
